Conservation Foundation of the Gulf Coast has protected 36 properties, nearly 9,860 acres, in fourteen years, creating preserves and conservation areas across four counties. The Foundation collaborated with 56 not-for-profit and for-profit organizations in the past year. Approximately 1000 individuals annually support the mission of Conservation Foundation. Cumulatively over the past fifteen years, revenues totaled more than \$47,100,000 coming from contributions, grants, and other program fees such as contract work with Sarasota County's environmentally sensitive land acquisitions program.

Continuing our commitment to youth education and community engagement, Conservation Foundation's Youth in Nature initiative engaging at-risk youth in our region in a variety of nature experiences continues to grow. Our second annual Feast Upon the Fields fundraiser was an even bigger success engaging more and different community members.
