In its 18 years, Conservation Foundation of the Gulf Coast has protected 46 properties totaling 18,324 acres, creating preserves and conservation areas across five counties. The Foundation collaborated with 55 private, public, and not-for-profit organizations in the past year. The Foundation's mission is supported by over 1,600 donors annually. Cumulatively over the past 18 years, total revenues exceeded \$56,300,000 derived from contributions, grants, and other program fees such as contract work with Sarasota County's environmentally sensitive land acquisitions program. The Foundation's education programs include programming for youth and adults including our Next Gen Conservation and Youth in Nature programs.

Conservation Foundation protects land and water for the benefit of people and nature. A nationally accredited land trust, we partner with landowners, businesses, government, and the community to identify critical land parcels and protect them in perpetuity. Our urgent work is accomplished by purchasing natural areas, holding voluntary land conservation agreements, creating and restoring native habitats, and educating for responsible land and water stewardship. We continue to steward natural areas on twenty different properties totaling over 2,500 acres. This includes scrub and pine flatwood restoration on Pine Island in Lee County, Myakka River restoration in Sarasota, and scrub restoration in Myakka City. Our work contributes to water quality, flood prevention, wildlife corridor connectivity, habitat protection, and unique public access, benefiting all those who call our region home. Despite the ongoing pandemic, in 2021 we completed a massive, landowner outreach effort across four counties - Manatee, Sarasota, Charlotte, and Hardee - in which we identified hundreds of environmentally significant parcels of land and reached out to their landowners to begin establishing relationships. We also ensured our ability to quicken the pace of conservation by increasing our staff with four new positions. These additional roles allow us to save more land faster, engage more people in nature, and support our growing conservation community. Our youth education programs continue to expand in both the number of partner organizations and counties we reach
