In its 17 years, Conservation Foundation of the Gulf Coast has protected 46 properties totaling 18,291 acres, creating preserves and conservation areas across five counties. The Foundation collaborated with 55 private, public, and not-for-profit organizations in the past year. The Foundation's mission is supported by over 1,600 donors annually. Cumulatively over the past 17 years, total revenues exceeded \$53,500,000 derived from contributions, grants, and other program fees such as contract work with Sarasota County's environmentally sensitive land acquisitions program.

The valuation is reflected as "Program Expenses" in the statements of activities.

Despite the COVID-19 pandemic, FYE 2020 was a great year! The year's significant activities were the permanent protection of 6,208 acres represented by the 5,777 acre Orange Hammock Ranch; 363 acre Myakka Headwaters Preserve; 40 acre Old Miakka Preserve Expansion; and the 28 acre Manatee Audubon Felts Preserve. As a nationally accredited land trust, we identify significant land parcels and work with landowners, philanthropists and governments to preserve and protect these lands in perpetuity. These properties will contribute to water quality, flood prevention, habitat protection, and unique public access. We unveiled our new, three-year strategic plan, The Call to Lead and published a new Vision Statement: We envision a future where the human and natural worlds of Southwest Florida flourish together. We revised our Mission Statement: To protect the land and water of Southwest Florida for the benefit of people and nature. We created our first Advocacy Team in Manatee County, partnered with Trust for Public Land and The Manatee Fish and Game Association to successfully place on the November ballot a bond referendum for a dedicated land protection funding source. Despite the pandemic, we continued our commitment to community engagement by pivoting our youth education programs to on-line events and continued to accomplish our mission by acquiring and maintaining conservation easements and owning nature preserves; educating for responsible land stewardship; and, collaborating with individuals, organizations and communities. We were innovative in how we engaged our conservation community and the public's awareness in the value of land conservation and our donor base grew by 70 percent.
