In its 19-year history, Conservation Foundation of the Gulf Coast has protected 56 properties totaling 19,212 acres, creating preserves and conservation areas across five counties. The Foundation collaborated with 55 private, public, and not-for-profit organizations in the past year. The Foundation's mission is supported by over 1,600 donors annually. Cumulatively over the past 19 years, total revenues exceeded \$58,100,000 derived from contributions, grants, and other program fees such as contract work with Sarasota County's environmentally sensitive land acquisitions program. The Foundation's education programs include programming for youth and adults including our Next Gen Conservation and Youth in Nature programs.

If an appraisal is not available, the conservations easement is valued based on the assed value of the property by the county tax appraiser. This value is adjusted based on our experience with similar properties to determine the value of the conservation easement.

Conservation Foundation protects land and water for the benefit of people and nature. A nationally accredited land trust, we partner with landowners, businesses, government, and the community to identify critical land parcels and protect them in perpetuity. Our urgent work is accomplished by purchasing natural areas, holding voluntary land conservation agreements, creating, and restoring native habitats, and educating for responsible land and water stewardship. We continue to steward natural areas on twenty-six different properties totaling over 3,000 acres. This includes scrub and pine flatwood restoration on Pine Island in Lee County, Myakka River restoration in Sarasota, and scrub restoration in Myakka City. Our work contributes to water quality, flood prevention, wildlife corridor connectivity, habitat protection, and unique public access, benefiting all those who call our region home. This year, we also conserved the approximately 300 acre Bobby Jones Golf Complex in the City of Sarasota so that it will always be a public park and to allow for wetland restoration which will improve the water quality in the Philippi Creak and Sarasota Bay. We added another staff person, a Nature Interpreter, to bolster our community education program. Our youth education programs continue to expand in both the number of partner organizations and counties we reach through programming. We continue to be innovative in how we engage our constituents and increase the public's awareness of the value of land conservation, bringing us ever closer to a future in which the human
